Restricted License:

Suggested to change the language to align with the direction that approved teacher program direction. This would allow ESDs or Community Colleges to be the sponsoring agency.

(2) Sponsorship: The Restricted CTE Teaching License requires educational agency sponsorship. The sponsoring educational agency must be identified and verified by the official CTE application through the Oregon Department of Education.
