1 2 OF THE STATE OF OREGON STIPULATION OF FACTS AND 3 In the Matter of the AL ORDER OF DENIAL OF 4 Administrator License of 5 PHILLIP R. HALL 7 On March 16, 2011, Hall was internally referred for investigation regarding 8 teaching without the proper license. After review of the matters alleged, Hall and the Commission agree that their 9 respective interests, together with the public interest, are best served by a stipulation to 10 certain facts and the denial of his substitute teaching license application. 11 By signing below, Hall acknowledges, understands, stipulates, and agrees to the 12 following: (i) he has been fully advised of his rights to notice and a hearing to contest the 13 findings of fact, conclusions of law, and order set forth below, and fully and finally 14 waives all such rights and any rights to appeal or otherwise challenge this Stipulation of 15 Facts and Final Order; (ii) this Stipulation and Final Order is a public document and 16 disclosed to the public upon request to the Commission; (iii) this Stipulation and Final 17 Order is contingent upon and subject to approval and adoption by the Commission. If 18 the Commission does not approve and adopt this Stipulation and Final Order, then 19 neither Hall nor the Commission are bound by the terms herein; (iv) he has fully read 20 this Stipulation and Final Order, and understands it completely; (v) he voluntarily, 21 without any force or duress, enters into this Stipulation and Final Order and consents to 22 issuance and entry of the Stipulated Final Order below; (vi) he states that no promise or 23 representation has been made to induce him to sign this Stipulation and Final Order; 24 and (vii) he has consulted with an attorney regarding this Stipulation and Final Order 25 and has been fully advised with regard to his rights thereto, or waives any and all rights 26 to consult with an attorney prior to entering into this Stipulation and Final Order and 27
