The Notice was sent via U.S. First 11 Class Mail and U.S. Certified Mail Receipt 7008 1140 0002 8581 2171, to the address on file with the 12 Commission. The U.S. Certified Mail receipt was returned to the Commission on October 14, 2008, 13 14 signed by Joseph Garner. The Notice of Opportunity of Hearing, dated October 9, 2008, and signed 15 by Victoria Chamberlain, Executive Director, stated: "You, Joseph Tracy Garner, are entitled to a hearing on the proposed action of the 16 Commission. If you want a hearing, you must file a written request for a hearing with 17 the Commission within 21 days of the date of this notice. Attached to this notice is a 18 copy of the procedures, right of representation and other rights of parties relating to the 19 conduct of a hearing as required under ORS 183.413(2)." 20 21 Mr. Garner did not request a hearing. The Commission, therefore, finds Mr. Garner to 22 be in default and enters the following findings of fact, conclusions of law and order, based on 23 24 the files and records of the Commission concerning this matter. **FINDINGS OF FACT** 25 26 1. Mr. Garner has been licensed by the Commission since January 31, 1990. The Commission issued Mr. Garner a Standard Teaching License on July 18, 2007, valid until July 17, 27 2012, with Basic Health and Standard Social Studies endorsements. 28 2. On September 19, 2008, Mr. Garner plead guilty to and was convicted in the Circuit Court 29 of the State of Oregon for the County of Malheur, of seven counts of online sexual corruption of a 30 child in the second degree, (ORS 163.432) a class C felony. A conviction for this crime constitutes 31 gross neglect of duty in violation of OAR 584-020-0040(1)(p) and ORS 342.143(3)(a)(A). 32
