On March 6, 2002, Portland Public Schools' Board of Education approved a resolution electing Timothy Thomas to third-year probationary status as a part-time teacher for the 2002-03 school year.

On August 27, 2002, Portland Public Schools terminated Timothy Thomas for 2. abandonment of his position. Timothy Thomas did not turn in grades for his students at the end of the 2001-02 school year.
