## BEFORE THE TEACHER STANDARDS AND PRACTICES COMMISSION 2 OF THE STATE OF OREGON 3 4 In the Matter of the DEFAULT ORDER OF REVOCATION OF 5 ) **Educator License of** ) RIGHT TO APPLY 6 BEAUDOIN, WILLIAM GEORGE 7 On September 5, 2014, the Teacher Standards and Practices Commission 8 (Commission) issued a Notice of Opportunity for Hearing to William George Beaudoin 9 (Beaudoin) in which the Commission charged him with Gross Neglect of Duty. The Notice 10 11 was sent via U.S. First Class Mail and U.S. Certified Mail Receipt 7012 1010 0003 2804 4623 to the address on file with the Commission. The Notice designated the Commission 12 file as the record for purposes of proving a prima facie case. Both the Certified Mail and the 13 regular mail was not returned to the Commission. The Notice of Opportunity of Hearing, 14 dated September 5, 2014, and signed by Victoria Chamberlain, Executive Director, stated: 15 "IF A REQUEST FOR HEARING IS NOT RECEIVED WITHIN THIS 21-DAY 16 PERIOD. YOUR RIGHT TO A HEARING SHALL BE CONSIDERED WAIVED 17 UNLESS YOUR FAILURE TO REQUEST A HEARING WAS BEYOND YOUR 18 REASONABLE CONTROL. IF YOU DO NOT REQUEST A HEARING OR IF YOU 19 FAIL TO APPEAR AT A HEARING, THE COMMISSION WILL ADOPT AN ORDER 20 OF DEFAULT WHICH MAY INCLUDE THE REVOCATION OR SUSPENSION OF 21 YOUR LICENSE OR OTHER DISCIPLINE." 22 23 Beaudoin did not request a hearing. The Commission, therefore, finds Beaudoin to be in 24 default and enters the following findings of fact, conclusions of law, and final order, based 25 on the files and records of the Commission concerning this matter. 26 27 FINDINGS OF FACT 28 1. William Beaudoin has been licensed by the Commission since June 23, 2011. 29 Beaudoin's Transitional Administrator License with an endorsement in Administrator 30 (ALL LVL), was issued June 23, 2011, and expired on June 23, 2014. During all relevant 31 times, Beaudoin was employed by the Blachly School District, also known as the 32 Triangle Lake Charter School. 33 2. On August 29, 2013, the Commission received a report indicating Beaudoin had 34 violated professional standards established by the Commission. Specifically, Beaudoin 35 assigned employees to teach courses for which they were not properly licensed or 36 registered to teach, including himself. Investigation determined that during the 2011-

1	2012 school year, Beaudoin assigned Lisa Lee Wagner to teach career classes without			
2	either a valid teaching license or a valid charter school registration. It was further			
3	determined that Beaudoin assigned Debra Werner to teach a culinary arts course			
4	during the 2012-2013 school year. At no time, while Werner taught this course, did she			
5	have a valid teaching license or a valid charter school registration. It was also			
6	determined that during the fall of 2012, Beaudoin assigned himself to teach an elective			
7	class when Beaudoin did not have a valid teaching license or charter school registration			
8	that allowed Beaudoin to teach such course work. In the course of the Commission's			
9	investigation, Beaudoin misrepresented his knowledge of the mentioned			
10	misassignments.			
11	CONCLUSIONS OF LAW			
12	Beaudoin's conduct constitutes gross neglect of duty in violation of ORS			
13	342.175(1)(b); OAR 584-020-0040(4)(n) as it incorporates OAR 584-020-0010(5) (Use			
14	professional judgment); OAR 584-020-0040(4)(0) as it incorporates OAR 584-020-			
15	0035(2)(a) (Apply for, accept, offer, or assign a position of responsibility on the basis of			
16	professional qualifications, and will adhere to the conditions of a contract or the terms of			
1.7	the appointment); OAR 584-020-0040(4)(c) (Falsification of any document or knowing			
18	misrepresentation directly related to licensure, employment, or professional duties); and			
19	OAR 584-020-0040(4)(i) (Assigning an educator in violation of licensure requirements).

21	The Commission's authority to impose discipline in this matter is based upon ORS 342.175.			
22				
23	FINAL ORDER			
24	The Commission hereby revokes William George Beaudoin's right to apply for			
25	licensure.
