

2. On or about August 30, 1993, Mr. Kennedy was convicted of DUII in Douglas County District Court, Roseburg, Oregon.

3. On or about February 2, 1998, Mr. Kennedy was convicted of DUII in Linn County Circuit Court, Albany, Oregon.

4. On or about September 20, 1999, Mr. Kennedy was convicted of Disorderly Conduct in Municipal Court for the City of Roseburg, Oregon.

5. On or about November 1, 1999 and November 15, 1999, Mr. Kennedy was convicted of Contempt of Court-Violation of Restraining Order in Douglas County Circuit Court, Roseburg, Oregon.

CONCLUSIONS OF LAW

1. The conduct described in Finding of Fact Number 1 constitutes gross neglect of duty in violation of OAR 584-020-0040(5)(c).

2. The conduct described in Finding of Fact Number 2 constitutes gross unfitness in violation of OAR 584-020-0040(5)(c).

3. The conduct described under Finding of Fact Number 3 constitutes gross neglect of duty in violation of OAR 585-020-0040(5)(c).

4. The conduct described in Finding of Fact No. 4 constitutes gross unfitness in violation of OAR 584-020-0040(5)(c).

5. The conduct described in Finding of Fact No. 5 constitutes gross unfitness in violation of OAR 584-020-0040(5)(c).

Any one of the findings of facts set forth above are a sufficient basis standing alone for denial of licensure pursuant to OAR 584-020-0040(3). The Commission's authority to deny licensure in this matter is based upon ORS 342.143.

2 The Commission denies issuance of a teaching license to Patrick John Kennedy.
