Mr. Brown also violated Standards by answering the character tions on the Application for Licensure "no" indicating he had no arrests or ictions. In conjunction with the Notice of Opportunity for Hearing, the Executive etary proposed to Mr. Brown a Stipulation and Order as follows. After review of natters alleged the parties have agreed that their respective interests, together the public interest, are best served by a Stipulation to certain facts and the sition of a reprimand and a period of probation. 21		STIPULATED FINDINGS OF FACT
22	Dura	nt Brown and the Commission agree that the following facts are true:
23 24 25	1.	Durant Brown holds a Professional Technical Teaching License for construction valid in Canby School District from September 4, 1996 to March 4, 1997. The expiration date was extended 60 days making it valid until May 4, 1997.
26 27 28 29 30 31	2.	On or about August 30, 1996, Brown made an application for licensure and submitted fingerprint cards as required. Brown answered "no" to all character questions on Section D of the Application Form C-1. A report from the FBI indicated that Brown had convictions in December 1975 for Forgery I and Theft II, September 1975 for Forgery I and May 1976 for Probation Violation. The report also listed an arrest on March 31, 1994 for Theft II, however no disposition of this arrest was listed.
33 34 35 36 37 38	3.	On request, Brown provided certified true copies of the court dispositions and his explanation of the events leading up to each arrest along with an explanation as to why he failed to report the convictions on his C-1 Application Form. Brown explained that the three arrests and convictions in 1975-76 were not separate, but stemmed from a single case of Theft to which he pled guilty and was given three years' probation. He was convicted for Probation Violation because he left the United States without permission from his probation officer.

1 2 3 4	4.	Brown also provided an explanation of the March 1994 arrest and conviction for Theft II. Although he admitted to theft of a Nintendo game, he failed to provide a fully credible explanation of the circumstances under which he left the store without paying for the game.		
5 6 7	5.	Brown explained his failure to report these crimes on his application form stating that he "felt they had been removed from his record and did not have any relevance to teaching building construction."		
8 9	6.	Brown has been employed at Canby School District since August 1996 and has performed to the district's satisfaction during this school year.		
10 11 12 13 14 15	The parties acknowledge that upon execution of this Stipulation the Commission will enter an Order of Public Reprimand and period of probation with respect to Brown's teaching license. This Stipulation is contingent upon approval and adoption of the Order by the Commission. If the Commission does not adopt this Order, neither Durant Brown nor the Commission are bound by these stipulations and Mr. Brown retains all rights to a hearing on the allegations.

27 28 29 30	Forge record	commission finds that Brown's failure to report 1975-76 convictions for Theft, ry, and Probation Violation because he believed they were removed from his does not constitute justification for his answers of "no" to questions on prior ctions. However, the Commission agrees that the length of time that has elapsed

1 2	since these convictions makes them relatively insignificant with regard to teaching building construction in 1996-97.
3 4 5 6 7 8 9	Brown's failure to report his arrest and convictions for theft of a Nintendo game in 1994 is a substantially more egregious violation of Standards. His failure to candidly and fully disclose the circumstances regarding his arrest on leaving the store without paying for the game raises further concern about Brown's fitness to serve as an educator. The public has high expectations regarding the integrity of teachers and Brown's behavior fails to meet that test. For these reasons the Commission elects to impose a public reprimand and relatively long period of probation as sanctions for Brown's actions. ORDER
12 13	1. The Commission imposes a Public Reprimand on Durant Brown and this Order shall serve as the reprimand.
14 15 16	2. The Commission places Brown on probation for a period of three years commencing on the date of the Commission's approval of this Order and subject to the following conditions:
17	(a) Brown shall violate no law;
18 19	(b) Brown shall comply with all Standards for Competent and Ethical Performance of Oregon Educators under OAR 584, Division 20.
20 21 22 23	Violation of any terms of Brown's probation shall constitute a basis for the Commission to charge Brown with further violation of the Standards for Competent and Ethical Performance of Oregon Educators, after first providing Brown notice and opportunity for hearing on the issue of whether he violated his probation.
