After review of the matters alleged, Shoff and the Commission agree that their respective 9 10 interests, together with the public interest, are best served by a stipulation to certain facts, the 11 imposition of a six (6) month suspension of Shoff's right to apply for an Oregon educator license. 12 This document sets forth the facts upon which the parties have agreed and the stipulated 13 sanction to be imposed. Shoff stipulates that there is sufficient evidence in the Commission's files and 14 records to support the findings of fact, conclusions of law, and order set forth below. 15 By signing below, Shoff acknowledges, understands, stipulates, and agrees to the following: (i) 16 he has been fully advised of his rights to notice and a hearing to contest the findings of fact, 17 conclusions of law, and order set forth below, and fully and finally waives all such rights and any rights 18 to appeal or otherwise challenge this Stipulation of Facts and Final Order of Suspension of right to 19 apply (Stipulation and Final Order); (ii) this Stipulation and Final Order is a public document and 20 disclosed to the public upon request by the Commission; (iii) this Stipulation and Final Order is 21 contingent upon and subject to approval and adoption by the Commission. If the Commission does 22 not approve and adopt this Stipulation and Final Order, then neither Shoff nor the Commission are 23 bound by the terms herein; (iv) he has fully read this Stipulation and Final Order, and understands it 24 completely; (v) he voluntarily, without any force or duress, enters into this Stipulation and Final Order 25 and consents to issuance and entry of the Stipulated Final Order below; (vi) he states that no promises 26 or representation has been made to induce him to sign this Stipulation and Final Order; and (vii) he 27 has consulted with an attorney regarding this Stipulation and Final Order and has been fully advised 28 with regard to his rights thereto, or waives any and all rights to consult with an attorney prior to Page 1 STIPULATION OF FACTS AND FINAL ORDER OF SUSPENSION OF RIGHT TO APPLY FOR

3		STIPULATION OF FACTS
4	1)	Shoff has been licensed as an Educator in Oregon since August 27, 1980. Shoff held a Standard
5		Teaching License, with endorsements in Basic Physical Education (018) and Standard Health
6		Education (018), valid from April 19, 2013, through April 18, 2018. During all relevant times,
7		Shoff was employed by the Lake Oswego School District. Shoff has not made application for
8		renewal.
9	2)	On July 20, 2015, the Commission issued Shoff a Notice of Opportunity for a Hearing. On August
10		4, 2015, Shoff requested a hearing, on January 28, 2016, a pre-hearing conference was held and a
11		hearing date of June 30, 2016 through July 1, 2016, was established. On February 16, 2016, the
12		Commission withdrew its referral, and cancelled the hearing in order to conduct additional
13		investigation. On December 29, 2016, the Commission issued Shoff an amended Notice of
14		Opportunity for a Hearing and on January 4, 2017, Shoff requested a hearing.
15	3)	On January 16, 2015, the Commission received a report from the Lake Oswego School District
16		alleging Shoff had engaged in unprofessional conduct. Commission investigation determined that
17		on or about December 30, 2014, while coaching a boy's high school basketball game, Shoff
18		displayed unprofessional conduct. The Lake Oswego School District determined Shoff violated
19		local policy and issued Shoff a written reprimand and removed Shoff from his coaching duties.
20		Effective April 19, 2015, Shoff resigned his employment with the Lake Oswego School District.
