21 22 23 24	The notice of opportunity for hearing was sent by U.S. Certified Mail, Return Receipt Requested. #P 412 422 542. The noticed was signed by Newton and returned to TSPC. Mr. Newton did not request a hearing.

26 27 28 29 30	1.	Gene Allen Newton held a Standard Teaching License valid from January 15, 1993 until January 4, 1998 and a Basic Administrative License valid from September 6, 1991 until January 4, 1994.	
31 32 33 34	2.	On or about April 2, 1998, Gene Allen Newton was asked by Dr. Mark Anderson, Associate Superintendent for Human Resources and Management Services, Spokane Public Schools, to answer questions about an alleged inappropriate sexual relationship with a female student.	
35 36 37 38	3.	Mr. Newton resigned from his teaching position with the district rather than meet with Dr. Anderson and refused to answer any questions about the allegations.	
39 40 41 42	4.	Mr. Newton voluntarily surrendered his Washington Initial Teacher Certificate, endorsed for K-12 music to Dr. Anderson who in turn returned the Certificate to the Washington Superintendent of Public Instruction.	
43 44 45 46	5.	Mr. Newton did not contest when Washington Superintendent of Public Instruction notified him that surrender of his certificate would be reported to other states. He made no contact with TSPC to explain his actions causing the Washington SPI to notify TSPC of surrender.

49 50 51 52 53	Gene Allen Newton voluntarily surrendered his Washington Teaching Certificate while under investigation by Spokane Public Schools for allegations of an inappropriate sexual relationship with a female student.		

1	CONCLUSIONS OF LAW
2 3 4 5	Under OAR 584-020-0040, the Commission may find sexual contact with a student to constitute gross neglect of duty and grounds for revocation of rights to reinstate professional licenses under ORS 342.175 through 190.
6 7	ORDER
8 9 10	The Commission revokes Gene Allen Newtons' right to reinstate his Oregon Teaching and Administrative Licenses for gross neglect of duty.
