BEFORE THE TEACHER STANDARDS AND PRACTICES COMMISSION OF THE STATE OF OREGON DEFAULT ORDER OF DENIAL In the Matter of the OF TEACHING LICENSE AND Teaching License of 5 SUSPENSION OF RIGHT TO APPLY AMY McDONALD VALDEZ On May 21, 2004, the Teacher Standards and Practices Commission (Commission) 7 issued a Notice of Opportunity for Hearing to Amy McDonald Valdez (Valdez) in which the 8 Commission charged her with misconduct under ORS 342.175. The Notice was sent via U.S. 9 10 First Class Mail and U.S. Certified Mail Receipt 7003 2260 0000 8804 6525 to the address Ms. Valdez provided to the Commission on her application for licensure. The certified mail 11 12 receipt was signed and dated May 22, 2004. The Notice of Opportunity of Hearing, dated May 21, 2004, and signed by Victoria Chamberlain, Executive Director, stated: 13 14 "You, Amy McDonald Valdez, are entitled to a hearing on the proposed action of the Commission. If you want a hearing, you must file a written request for a 15 hearing with the Commission within 21 days of the date of this notice. Attached to this notice is a copy of the procedures, right of representation and other rights of parties relating to the conduct of a hearing as required under ORS 183.413(2)." 19 20 Ms. Valdez did not request a hearing. The Commission, therefore, finds 21 Ms. Valdez to be in default and enters the following findings of fact, conclusions of law 22 and order, based on the files and records of the Commission concerning this matter. 23 FINDINGS OF FACT 24 1. On January 27, 2004, Ms. Valdez signed and submitted an Application for Educator 25 License Form C-1 requesting a Restricted Substitute Teaching License. The application was 26 27 sponsored by the Clackamas Education Service District. 2. On the character question section of the application, Ms. Valdez responded 28 affirmatively to question 8, "Have you ever been convicted or been granted conditional 29 discharge by any court for: (a) any felony; (b) misdemeanor...?" and question 10, "Have you 30

ever entered a plea of guilty or No Contest relative to any charge for an offense listed in question 8?" Ms. Valdez disclosed a single felony conviction for Identity Theft II, ORS 165.800, in Clackamas County Circuit Court.

- 3. Ms. Valdez failed to disclose and provide court documents for additional criminal convictions. FBI and the Oregon court records indicate that:
- a. On March 23, 1993, Ms. Valdez was convicted of Fraud-Illeg use Credit Cards,
 a felony, in Houston, Texas;
- b. On October 30, 2000, Ms. Valdez was convicted of Theft III, a misdemeanor,
 and Tampering with Drug Records, a felony, in the Circuit Court of the State of Oregon for the
 County of Washington; and
- 11 c. On August 13, 2001, Ms Valdez was convicted of Theft II, a misdemeanor, in
 12 Beaverton Municipal Court, Beaverton, Oregon.

CONCLUSIONS OF LAW

Ms. Valdez' knowing misrepresentation directly related to licensure constitutes Gross Neglect of Duty in violation of OAR 584-020-0040(4)(c). These convictions, in addition to failure to disclose them, are basis for denial of licensure pursuant to OAR 584-050-0006(1), (3) and (5). The Commission's authority to impose discipline in this matter is based upon ORS 342.175.
